

SGP FUNDS


- Planning Grants/Maximum \$5,000
- Full Size Grants/Maximum \$50,000
- Strategic Grants/Maximum \$150.000
- Capacity Development Grants (10% of total grants)

CRITERIA FOR GRANTEES INCLUDE

- Local NGOs, CBOs, CSOs, scientific organizations or grass root
 organization.
- Must be able to formulate a project addressing a call in one or more of GEF focal areas
- Project must align with the SGP Country Programme Strategy for the Operational Phase (OP) during the project implementation.
- Legally registered to operate in Sierra Leone
- Must have office space / contact address and bank account.

SMALL GRANTS PROGRAMME ACHIEVEMENTS IN OPERATIONAL PHASE 5 & 6

- In the 5th Operational Phase- OP5 (July 2011- June 2015), SGP successfully funded 52 projects.
- In the 6th Operational Phase-OP6 (July 2015-June 2019), SGP has funded 57 projects, 24 of these projects end in September 2019.
- SGP OP5 and OP6 total projects= 109 projects
- These projects have demonstrated that community actions can maintain the fine balance between human needs and environmental imperatives.


