

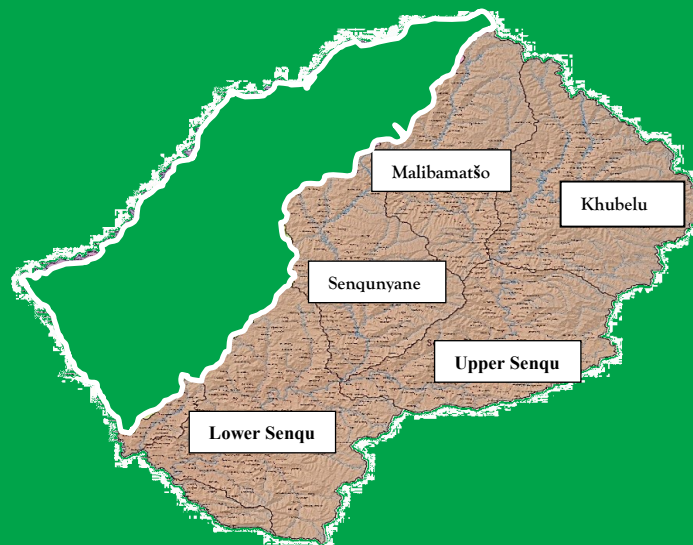
Project Financing

The GEF SGP funding covers the incremental costs related to projects. Incremental costs are additional costs associated with transforming a project with national benefits into one with global environmental benefits. The GEF is a co-financier operating on a 1:1 partnership arrangement in financing of projects. The Programme provides small grants, up to USD 50 000.00, directly to CSOs or other recognized community entities for environmental projects. Contribution by grantees may be in cash and/or in kind and can be raised through partnerships with donors, government, academic institutions, private sector, business sector and other stakeholders.

What is The GEF Small Grants Programme?

The Global Environment Facility (GEF) Small Grants Programme (SGP) is a corporate programme of the GEF, implemented by the United Nations Development Programme (UNDP) and it is executed by the United Nations Office for Project Services (UNOPS). Grants are made directly to Civil Society Organizations (CSOs) including national and local Non Governmental Organizations with priority for Community Based Organizations, Farmers Associations, Scientific Community, Women Groups and Youth and Children Organizations and other recognized community entities.

The SGP recognizes the key role CSOs play as a resource and constituency for environment and development concerns. These entities should be involved directly or indirectly in natural resources management and other activities that support livelihoods, empower communities and most importantly contribute towards environmental protection.

GEF SGP's Goal in Operational Phase 6 (OP6)

"Effectively support creation of environmental benefits and safeguarding of the global environment through community and local solutions that complement and add value to national and global level action".

What's our story?

SGP in Lesotho started financing projects in 2008 and has succeeded in funding and providing technical support for more than 50 projects implemented by more than 40 CSOs country wide. The grant making has generated lessons that will inform grant making in OP6. For OP6, SGP has adopted a landscape/seascape approach to better focus grant-making and promote strategic programming and clustering of small grant projects with the aim to achieve greater impact and lead to synergies and opportunities for scaling up.

Our priority landscape in OP6?

Following a consultative process, the Senqu River Basin is prioritized for SGP intervention in OP6. This is in recognition of the ecosystem features:

- ♦ *global significance* in terms of the GEF SGP focal areas,
- ♦ *opportunities for community action* and integrated *approaches*,
- ♦ *potential for synergy* with GEF full size projects and other programmes and government initiatives in the landscape.

However, **up to 30%** of available grants will be availed for strategic projects outside the priority landscape.

Eligible Activities?

SGP grant-making in OP6 will be guided by 4 "strategic initiatives" which are multi-focal in character. These are presented in the diagram on the next page.

SGP OP6 Strategic Initiatives and Typologies of Projects

1. Community landscape/seascape conservation

6. CSO-government policy and planning dialogue platforms

- ♦ *South-South Community Innovation Exchange*

Projects should address threats to one or more focal areas of the GEF SGP namely, *Biodiversity Conservation, Climate Change Mitigation, Sustainable Land Management and Sustainable Forest Management, Protection of Wetlands and Water Sources, and Reduction of Harmful Effects of Chemicals*, within the scope of the OP6 Strategic Initiatives highlighted above and within the Orange River Basin as the prioritized landscape for SGP intervention in OP6.
